## 3.2.2 Micro Enterprise Development Programmes (MEDPs)

Micro Enterprises Development Programme (MEDP) is an initiative for promotion of sustainable livelihood through vocational training in the State of Kerala. The

programmes are carried out in association with the local self government institutions in the State with the objective of providing hands on practical exposure to the participants in the manufacturing/production/providing services. The focus is on helping the participants to start activities in the small, tiny and cottage sectors thus enabling them to earn higher income to support their families. The Department of Local Self Government, Government of Kerala has recognised the Centre as an agency to conduct such programmes.

The Centre continued to organise MEDPs during the year also and completed 13 MEDPs all over the State. The trainees were selected from rural villages in association with the Local Self Government institutions and a majority of them were women. The details are as follows:

## 3.3 Review of Public Enterprises in Kerala – 2018-2019

Sponsored by Bureau of Public Enterprises, Government of Kerala

The annual Review of Public Enterprises in Kerala forms part of the budget documents of the State. The Review for the year 2018-19 was prepared by CMD, for the thirty second years in succession, on behalf of the Bureau of Public Enterprises, Government of Kerala. The Review for 2018-19 analyses the performance of the State Level Public Enterprises for the three years from 2016-17 to 2018-19.

The Review was presented during the Budget Session of 2020.

## 3.4 Highlights of Certain Major Activities undertaken by the Centre

#### 3.4.1 Survey of Transgender Persons in Kerala

**Background**: The Transgender community in Kerala faces several problems such as social discrimination, poor health, high dropout rate, low income, harassment and abuse, as revealed through surveys conducted. They face injustice in their families and public places, in schools, in workplaces, at markets and shops, emergency rooms, at hands of landlords, police officers, health care workers and other service providers. It is in this background that the Department of Social Justice, Government of Kerala (GoK) is planning to conduct a socio-economic census of all transgender persons in Kerala so as to develop an online platform for monitoring and supporting them.

**Aims & Objectives**: The proposed survey broadly aims at bringing transgender persons into mainstream society through assessing their individual needs and devising individual development plans. The specific objectives include (i) To identify all transgender persons spread across all districts in Kerala, (ii) To collect socio-economic

data of transgender persons thus identified and (iii) To prepare development plans, based on their socio-economic conditions and needs identified.

**Approach & Strategy**: It is proposed to follow a participatory and inclusive approach involving all stakeholders such as TG Justice Board, district TG Justice Committees, CBOs of TGs from all districts, domain area experts and TG Cell staff and officials of Social Justice Department.

#### 3.4.2 Efficiency, Transparency & Accountability of Civil Service and Linking Emoluments with Performance: Rapid Study of Recommendations of Pay Revision Commissions and Administrative

**Background**: The 11<sup>th</sup> Kerala Pay Revision Commission (PRC) was constituted vide G.O(Ms) No.414/2019/Fin dated 06/11/2019to study and make recommendations on revising the pay and allowances and other benefits of the State Government Employees including teaching and non-teaching staff of aided educational institutions, local bodies, etc. Besides the task of examining and suggesting modifications in pay and allowances and other service conditions, promotional avenues and fringe benefits of the Government Employees, the 11<sup>th</sup> PRC are also mandated to make suitable recommendations to enhance efficiency, social accountability and people friendliness of the civil service.

The 8<sup>th</sup>, 9<sup>th</sup> and 10<sup>th</sup> Kerala PRCs had made recommendations on improving efficiency, transparency and accountability of the civil service (Chapter X of the 8<sup>th</sup> PRC, Chapter 12 of the 9<sup>th</sup> PRC and Chapter 2 of the 10<sup>th</sup> PRC). The Administrative Reforms Commissions (ARC), both at the State and Central levels have also discussed these issues and made many suggestions to improve the effectiveness of the employees thereby ensuring good governance. The 10<sup>th</sup> PRC of the State and previous central ARC reports have also recommended linking of pay and promotions with performance of the employees. The Finance Commissions have also made broad suggestions on these aspects. However, some of these recommendations have not yet been taken up for implementation due to various reasons.

As a prelude to making further proposals on improving the competency of the civil service, the 11<sup>th</sup> PRC wishes to examine the recommendations of the previous PRCs, including the extent of implementation of these suggestions by the Government. The Study is in this context.

**Aim and Objectives**: The proposed Study broadly aims at examining the Reports of the earlier PRCs (Kerala) and ARCs with a view to identifying recommendations on improving the efficiency of the civil service and linking the pay with the performance of the employees. The specific objectives of the study include (i) To attempt a comprehensive review of the reports of the previous PRCs in Kerala and ARCs so as to identify and consolidate the recommendations made therein regarding improving efficiency, transparency and accountability of the civil service in the State, (ii) To

examine and consolidate recommendations of the earlier Kerala PRCs and ARCs on the subject of linking performance of employees with their pay and allowances and (iii) To scan the suggestions on the above subjects made in the above documents which have not been implemented but are of contemporary relevance and could be considered for implementation with modifications, if required.

#### 3.4.3 Accountability Mechanisms in Government and Public Grievance Redress

The study focuses on the Accountability Mechanisms in Government and Public Grievance Redress and to explore the role of the concerned institutions as a promoter of good governance, grievance redressal and for ensuring accountability and transparency in Government. The study aims to identify the barriers/hindrances of the public in accessing the service of these mechanisms. The study will also focus on the issue of co-ordinated or joined up functioning of these institutions for better results. The study was conducted among functionaries/agencies involved in anti-corruption or corrective mechanisms in government functioning. To understand the public grievance mechanisms in Government and its effectiveness, the functioning of various Commissions are studied.

#### 3.4.4 Consulting and Project Management Support to KIIFB

The Centre for Management Development (CMD) has been appointed as a service provider to the Kerala Infrastructure Investment Fund Board (KIIFB) from the year 2017-18 onwards. KIIFB is a Government of Kerala owned institution that provides investment for critical and large infrastructure projects in the state. It aims to dynamically mobilise funds for the infrastructure development of Kerala, including major land acquisition needs of the State. KIIFB has recourse to the advanced financial instruments approved by SEBI and RBI, and is expecting an upspring of sustainable infrastructure development of the state with employing cutting edge technology in the funding, planning, implementation and monitoring phase. The project implementation of the KIIFB funded projects are carried out through about 23 different Special Purpose Vehicles (SPVs) covering different infrastructure sectors like roads and highways, bridges and elevated structures, educational infrastructure, water supply schemes, electrical, IT, health, sports, transport, agriculture processing, industries, etc. The various support functions offered by CMD to KIIFB are detailed below.

• CMD carries out thorough **Technical Appraisals** of the **Detailed Project Reports** (**DPRs**) being prepared by the SPVs for different projects being taken up for KIIFB funding. The Technical Appraisal process is a very comprehensive due diligence process, undertaken by KIIFB prior to the approval of projects. The appraisal process involves scrutiny of the Detailed Project Reports prepared by the Special Purpose Vehicle (SPVs) appointed by the Government. DPRs are forwarded by KIIFB to CMD for appraisal. This third party appraisal is general and technical in nature for its compliance to client requirements, standards and specifications in line with the manuals & guidelines issued by KIIFB from time to time and in accordance with the National Building Code, Ministry of Road Transport & Highways (MoRTH), GoI standards and CPWD/State PWD works manuals. KIIFB, CMD & its associated consultants are working closely in-hand with the SPVs during the process with regular meetings and field verification visits. A number of Sectoral Experts for the technical appraisals and management experts for the general appraisals selected by CMD are working in close co-ordination with the Project Appraisal Division of KIIFB for the process. Detailed Appraisal Reports are furnished to KIIFB. Based on this, approval for the funding of the project is accorded by KIIFB. So far CMD has evaluated and appraised more than 600 projects of KIIFB, worth over Rs. 40,000 Crores. It is estimated that this technical appraisal process by CMD may result in a savings of more than Rs. 3,000 Crore to KIIFB. During 2019-20, appraisal has been completed for103 projects worth of Rs. 6164.23 Core for the final approval of the KIIF Board.

- The Capacity Building of the various officials of KIIFB and various SPVs on various tools and techniques being adopted by KIIFB for project implementation, management and monitoring is also undertaken by CMD. This is being conducted as a complete handholding programme based on a comprehensive Training Needs Assessment of the offices of SPVs all over Kerala, class room trainings with real case studies in different parts of Kerala and continuous follow up of the trainees to sort out any issue they are facing in the implementation of their learnings. During 2019-20, CMD has conducted 9 such sessions for 183 participants.
- Conducting Workshops on new technologies in the areas of Infrastructure Development. During the period two workshops were conducted for KIIFB and SPVs. A one-day Workshop on Steel Structure Bridges for officers of SPVs and KIIFB was held on 3<sup>rd</sup> Dec, 2019 with 39 participants. It mainly focused on 'Issues related to design, construction, contract and maintenance of steel-concrete composite bridge infrastructure in Kerala'. The target audience of the workshop is different stake holders concerned with the Bridge Infrastructure in the state of Kerala, such as Policy Makers, Engineering Department Chiefs, Technical Staff who are involved in road infrastructure executions and faculty from academia. This workshop covered the aspect of conceptual issues, design, construction and the contractual obligation aspects related to steel-concrete composite bridge infrastructure. This workshop was intended to pave way for use of newer bridge construction technologies in Kerala. M/s. Autodesk in association with CMD has organised an Event on "Advanced Technologies in Virtual Design and Construction" on September 26, 2019 in which we got wide participation of over 130 nos. from KIIFB, SPVs and other stake holders. The event was intended to provide a platform for exchange of best practices to meet the infrastructure needs of tomorrow.

- CMD functions as the **recruitment consultant of KIIFB** providing end to end solutions for recruitment of its officials across different levels and departments and also provides manpower support as required for its operations.
- CMD was entrusted to implement the latest technology like **Building Information Modelling (BIM) and Virtual Design & Construction (VDC) on a Pilot Phase** in KIIFB Projects .Four KIIFB funded projects, viz. Construction of Vytila Flyover, Kundannoor Flyover, Four-laning of NH 4766 Karamana-Kaliyikkavila Phase I, Reach 2 (Pravachambalam to Balaramapuram), Punalur Taluk Hospital – Construction of new block and augmenting basic infrastructure, were selected as pilot projects for BIM & VDC implementation. CMD has developed BIM models based on the data from SPVs and Drone and LiDAR survey. The project has been completed during the year 2019-20.
- CMD has also provided various procurement services to KIIFB by **Empanelment of** suitable agencies for Drone & LiDAR Survey, BIM and wet lease of equipments for Drone Survey. In this, Comprehensive RFP documents for Drone & LiDAR Surveys, Design Upgradation services, BIM were prepared and South India-wide tenders were floated (in national daily). Among the technically qualified agencies that passed the initial scrutiny, technical presentations were organised and financial bids of those who came on top of the list were considered to arrive at the list of empanelment (at lower rates). The selected agencies were intimated to KIIFB for issue of work order and execution of contract agreement.
- As per the request from KIIFB, CMD provided facility support to KIIFB to establish a **Technical Resource Centre (TRC)** with effect from 1st November, 2018 with a view to improve the delivery and implementation of technical advisory and new technology initiatives for better project implementation including design, cost and performance optimization in the post appraisal phase. The TRC is envisaged to function as an outsourced centre of KIIFB and Special Purpose vehicles (SPVs) of KIIFB. The TRC is functionally controlled by the Technical Inspection Wing (TIW) of KIIFB and administratively facilitated by CMD. During the year 2019-20, we have provided various services to TRC of KIIFB worth of 197 Lakhs.

# 3.4.5 Evaluation Study on Various Renewable Energy Programmes Implemented by ANERT

Agency for Non-conventional Energy and Rural Technology (ANERT), an autonomous organization functioning under Power Department is the State Nodal Agency for the Ministry of New and Renewable Energy (MNRE), Government of India, to carry out the Centrally Assisted Programmes in Kerala. With the growing importance of renewable energy, and ANERT being the nodal agency for implementation and propagation of Non-conventional sources of energy in the state, it is essential to assess/evaluate its programmes/schemes and their functioning and providing suggestions/action plan for

improving its performance. In this context the State Planning Board has decided to entrust the work of Evaluation study on various renewable energy programmes implemented by ANERT with CMD.

The overall objective of the study is to assess the performance of ANERT as an implementing agency of various renewable energy schemes, identify the causes for the shortfalls in the performance and make appropriate suggestions for improvement and further action and also assess the impact of the scheme as carried out so far. The study focuses on the sources of funding and expenditure incurred in connection with various renewable energy programmes and the process of implementation. The performance and the present status of equipment supplied by ANERT and maintenance support provided by the agencies will also be looked into. The benefits like energy generated/saved from various renewable energy sources undertaken by ANERT will also be a part of the study. The study involves collection of information from beneficiaries of various schemes, implementing officials, empanelled agencies and LSGDs. *The existing organization structure of ANERT will also be studied to know the constraints faced if any.* 

## 3.4.6 Impact Assessment of Flood/Landslides on Biodiversity and Ecosystem

The unprecedented floods during the monsoon season in 2018 have brought havoc in Kerala causing destruction to human life, property and economy in general. This has affected the way of living of the people especially in their vocation and avocation. The flora and fauna bore brunt of havoc in an irreparable fashion. It was the worst flood that Kerala had witnessed during the last 100 years. Thirty-five out of the fifty-four dams in the State had to be opened including the five overflow gates of the Idukki Dam. According to Government of Kerala, one-sixth of the total population had been directly affected by the floods and related incidents.After, the disastrous floods in 2018 that severely disturbed Kerala's Biodiversity, the Kerala State Biodiversity Board (KSBB) entrusted us to conduct a study on:

- 1. Impact Assessment of Flood/Landslides on Biodiversity and Ecosystem of Idukki district and Kuttanad.
- 2. Impact Assessment of Flood/Landslides on Biodiversity and Ecosystem of Pathanamthitta district and Tribal livelihoods in Idukki and Pathanamthitta district.

The methodology followed for primary data collection were Questionnaires, Focus Group Discussions, Semi-structured interviews, Inputs collected from Biodiversity Committee Members, discussion with affected farmers and tribes followed by Flora and Fauna Survey along with Water and Soil Analysis. Secondary data from Flood Management were also referred. A database was created based on the data collected on the extent of damage to Fauna and Flora in the respective Panchayats in the assigned districts.

#### 3.4.7 NDPREM - A Rehabilitation Programme for Overseas Returnees

NDPREM (NORKA Department Project for Returned Emigrants) is a rehabilitation programme for the oversees returnees formulated by the NORKA ROOTS. It was started as an attempt to support the overseas returnees for their livelihood generation. The programme enables the members to identify their strengths and skills and nurture them to be capable enough to start small enterprises. Various financial institutions such as State Bank of India, South Indian bank, Union Bank, Kerala State Backward Classes Development Corporation, SC/ST Development Corporation and Kerala State Pravasi Welfare Development Co-operative Society provide loans to returned emigrants for starting enterprises. NORKA ROOTS releases capital subsidy of 15% of the project cost and interest subsidy of 3% for the first four years to those beneficiaries who are regular in payment. As part of selection of beneficiaries NORKA ROOTS conducts orientation and screening. In order to become beneficiaries of the scheme, the NRKs have to register in the scheme through the NORKA ROOTS website. The applicants should possess minimum two years working experience abroad.

The major objectives of the programme are:-

- Development of a sustainable model for the proper rehabilitation of the returned emigrants.
- To provide necessary support for the returned emigrants for starting new enterprises as per the government norms
- To provide necessary guidance and advices on entrepreneurship
- To provide capital and interest subsidies to the eligible beneficiaries

In the existing process, the applicants who have worked abroad for at least two years and have obtained permanent residentship in India register online at the NORKA ROOTS website with personal details, pre-requisites such as the passport, a project report which details the prospects of the venture, marketability and feasibility of the project, etc. After preliminary screening of the applications under NDPREM, the applicants are invited for the orientation programme conducted by NORKA ROOTS, where awareness is imparted on NDPREM scheme, eligibility for receiving loan, relevance of training and skill development. The process of screening vests with NORKA ROOTS. The eligibility of the applicants with regard to genuinity of the relevant documents required to become eligible under the programme is verified. After the screening of applicants, the eligible applicants are recommended to respective banks/financial institutions. The beneficiaries are directed with a letter to the concerned banks from NORKA ROOTS and the beneficiaries are advised to approach the bank with necessary documents including project reports, collateral security, etc. The banks sanction the loan after necessary processing of their application and subsequent interaction with the beneficiaries.

## 3.4.8 Gothrajeevika - A Sustainable Livelihood Generation Programme for Tribal Community

Gothrajeevika was started as an effort towards supporting the ST community members for their livelihood. Identification of skills suitable for the tribal population and developing the skills through specific trainings was done. It enables the community members to get self employed/start small enterprises/get employed & bring them into forefront of the society. Generally urban-centred programmes which are not suitable for target beneficiaries, need for alternative sources of income, target group and their educational and skill levels, demand gap of unskilled labourers in housing/ construction sectors, etc., were those that triggered the formulation of such a programme.

The main objectives of the programme were:

- Creation of sustainable income generation sources through capacity building of ST community members
- Creation of employment opportunities through self employment ventures
- Enhancement of employability of the human resources from ST community to explore the existing opportunities in the skilled labour market
- To ensure economic and social upliftment of beneficiaries' living standards

The programme was implemented in phases. Under Phase I, 87 Opportunity Guidance Programme with a total participation of 12,900 tribes. This remains as one among the largest mass participation for a single scheme in the history of ST Department. Selection of Beneficiaries based on individual discussions and Identification of the Type of Training were the other activities under the phase. Under the Second Phase, identification of suitable locations for training, setting up of practical labs, Basic Orientation Programme, Practical Skill Development Programme and Basic Management Orientation Training were conducted.

Organization of all beneficiaries into SHGs on basis of their convenience was done under Phase 3. As on 11<sup>th</sup> October 2018, 35 societies completed registration in the common name of "Gothrajeevika ST Self Help Group". In addition to this, training was provided to the members regarding the functioning of groups. Bank accounts for the groups alone and joint account with TEO and officials of SHGs were started. Discussion was held with various stakeholders to ensure contractual works to the registered societies.

An estimated increase of 41% in the wages obtained by the beneficiaries of construction-oriented trainings (from Rs. 600 to Rs. 850). 120 beneficiaries reported that they are regularly engaged in private constructions and works.

## 3.4.9 Pre-Departure Orientation Programme (PDOP)

Every year hundreds of thousands of people from Kerala emigrate in search of job. The orientation and training that expatriates receive before departure have a major impact on the success of the overseas assignment. The areas that affect the cross-cultural adjustment process are work adjustment, interaction adjustment and general adjustment. Permeating all of those areas is the need culture familiarization. The protection of migrants can be enhanced through better training programmes and information dissemination about migration. A Pre Departure Orientation Programme (PDOP) which cover all these aspects is beneficial for the overseas job seekers to make them better adaptable to the cross cultural situation. The Pre Departure Orientation Programme (PDOP) is aimed at providing a person with the knowledge needed to survive in the target (cultural) situation and thereby equip them to interact and perform effectively in a different cultural context. Expatriates who are culturally adjusted can more easily establish good relationships and respect local colleagues and business partners.

The specific objectives of the PDOPs are:-

- Provide practical knowledge to those who are in the middle of processing migration or contemplating migration
- ✤ Create proper awareness among overseas job aspirants on safe and legal migration
- Aid participants in gaining a better understanding of difficulties expected in crosscultural situations
- Learn a practical approach for understanding different cultures around the globe

The target group of the PDOP is overseas job seekers. The job seekers will be normally grouped into those pursuing professional courses, those undergoing specialized coaching/training, professionals and workers currently employed in various sectors with no or limited experience working and living outside their own country and unemployed educated youth.

Awareness will be created among the overseas job seeker regarding the following aspects:-

- Culture Profile : Differences and similarity of the host and home country
- Country Briefing : General information about the host country
- Cultural Adaptation : Intercultural and Culture Shock training
- Professional etiquettes expected attitudes and behaviour at destination
- Labour laws prevailing in host countries
- Matters relating Visa stamping, immigration, baggage, customs clearance, etc
- Information relating employment contract and travel formalities

The participants were provided with training materials containing details about cross cultural understanding materials, immigration and customs and rules and knowledge on international flights and country profiles.

## 3.4.10 National Health Mission (NHM) Training Programme

The training programme was offered for the nominated Public Relation Officers (PROs) and Middle Level Officers (MLOs) of National Health Mission (NHM) working in various District, Taluk and Community level hospitals in Kerala. As the Public Relations Officers in health care settings are responsible for maintaining the desired image of a health care facility in the public eye, they must be knowledgeable about the internal workings of the hospital and must also be aware of its strategic objectives. The middle level officers are the 'sandwich' layer or the layer between the top-level officers and the lower level or the 'boots on the ground'. They act as a bridge between the decision makers and the ground level officers. They are at the receiving end form both sides and hence they are vital factor in the success of the mission. In this context the National Health Mission has decided to impart a three-day Management Development Programme to the PROs and MLOs of NHM to enhance their managerial skills, self-development, communication skills for improving effectiveness and efficiency of team members within the hospitals they work. The Centre conducted a quick training need assessment considering the future requirements/challenges of the PRO and MLO officials. Based on it we had conducted a three day residential training programme for the Officers of NHM focusing on the areas of managerial aspects, interpersonal relationship, communication skills, organisational behaviour, etc.

#### 4.0 INFRASTRUCTURAL FACILITIES

## 4.1 Library

During the year under report, the total number of books in the Centre's Library is 6371. The Centre subscribes to twelve periodicals and the bound volumes number 559.

## 4.2 **Computer Facilities**

All the academic staff and officers have been provided computing facilities with printing and round the clock internet facilities. During the year under report, the Centre has thirty computers, nine laptops and two LCD projectors.

## 4.3 Staff Position

As on March 31, 2020, the Centre had on its roll thirteen faculty members including the Director during the period under report. There are eleven numbers of supporting staff. (*Exhibit 3*). List of Chairmen & Directors are given in *Exhibit 4*.

#### GENERAL INFORMATION

Basis of preparation of Financial Statements:

## a. Use of estimates
