#### **Project Consultant**

- Candidate should clearly mention the marks scored in their qualifying examination in the application. The onus of proving the conversion from grade/CGPA to percentage of marks would rest with the candidate.
- Selected candidates shall be positioned at TRCMPU through the Centre for Management
