Candidates belonging to **Other Backward Classes** included in the Probability List are required to produce **Non Creamy Layer Certificate** as per GO(P) No.81/09/SC/STDD dated 26.09.2009 or that obtained through **e-district portal** in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018.

SC/ST Candidates are required to produce **Community Certificate (Form III / Digitally Signed)** issued by the Revenue Authority not below the Rank of Tahsildar.

6. The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the Probability List without further notice.
